Change water district budgets.

Change the state retirement:

A9010.8 from \$28,624.00 to \$30,138.00

B9010.8 from \$8,724.00 to \$9,487.00

DA9010.8 from \$14,752.00 to \$14,783.00

DB9010.8 from \$14,752.00 to \$14,783.00

Change fire district to reflect the \$5,841.00 reduction

Reduce A1220.1 from \$5875.00 to \$5750.00

Reduce A5010.2 from \$10,000.00 to \$0.00

Now therefore be it resolved that the Town Board hereby adopts the 2016 tentative budget as the 2016 Preliminary Budget.
