LOCAL LAW #1 OF 2017 AUTHORIZING

GAMES OF CHANCE BY PERMITTED ORGANIZATIONS

WITHIN THE TOWN OF ALBION,

COUNTY OF ORLEANS, STATE OF NEW YORK

Be it enacted by the Albion Town Board, County of Orleans, State of New York, as follows:

SECTION 1.

This Local Law is adopted pursuant to General Municipal Law Article 9-A of the State of New York and shall be known as "Games of Chance Local Law of the Town of Albion".

SECTION 2. DEFINITIONS

- A) The words and terms used in this Local Law shall have the same meanings as such words and terms and used in Municipal Law Article 9-A unless provided herein or unless or unless the context requires a different meaning.
 - B) As used in this Local Law, the following terms shall have the meanings indicated:
- The Chief Law Enforcement Officer of the County of Orleans means the Orleans County Sheriff.
- The Town of Albion means everything encompassed within the Town of Albion, County of Orleans, State of New York.

SECTION 3. GAMES OF CHANCE AUTHORIZED AND RESTRICTIONS

Pursuant to, and in accordance with, General Municipal Law §188(1) and other

applicable provisions of the Laws of the State of New York, it shall be lawful for any authorized

organization, upon obtaining a license therefore (as provided in General Municipal Law Article

9-A) to conduct games of chance within the territorial limits of the Town of Albion subject to the

provisions of this Local Law, the provisions of General Municipal Law Article 9-A and the rules

and regulations set forth by the New York State Racing and Wagering Board. The conduct of

such games of chance shall be subject to the restrictions imposed by General Municipal Law

§189. However, no games of chance shall be conducted on Easter Sunday, Christmas Day or

New Years Eve.

SECTION 4. CONTROL AND SUPERVISION

The powers and duties set forth in General Municipal Law §194(1-2) shall be exercised

by the Chief Law Enforcement Officer of Orleans County.

SECTION 5.

In accordance with the General Municipal Law §188(2) and Municipal Home Rule Law

§23(1), this Local Law shall not become operative or effective unless and until it shall have been

approved at the next general election held within the Town of Albion by the affirmative vote of a

majority of the qualified electors of the Town of Albion voting upon the proposition.
