The wages paid will be at a base rate of \$23.19 per hour.

Sick time will be at the new hire rate of 1 day/month.

Vacation time will be at a 10 year employee schedule 20 days (160 hours) to be prorated to 8

days (64 hours) for the remainder of 2018. Personal time will be 5 days (40 hours) to be prorated to 2 days (16 hours) for the remainder

of 2018.
