Chapter 45 - Dog Law

Amendment to Section 45 - 7 Fees:

- (a) The fee for a spayed/neutered dog will be \$10.00 (which includes the assessment of a \$1.00 surcharge for the purpose of carrying out animal population control) and the fee for an unsprayed/unnuetured will be \$20.00, (which includes the assessment of \$3.00 for the purpose of carrying out animal population control) with such fees being reviewed by the Town Board periodically and may be changed by a resolution of the Town Board, if deemed necessary.
- (b) All other items listed in Section 45 7 shall remain the same.

Section 13 - Repealer

This Local Law shall supersede all prior Local Laws, Ordinances, Rules and Regulations relative to the control of dogs within the Town of Albion, and they shall be upon the effectiveness of this Local Law, null and void.

Section 14 - Amendments to previous laws:

Local Law No. 1 of 2012 constitutes an amendment of Local Law No. 3 of 2010, Local Law No. 4 of 2004, Local Law No. 2 of 2002, Local Law No. 3 of 1990 and Local Law No. 4 of 1985 which establishes a Local Law "Dog Control Law".

Section 15 – This Local Law shall be effective January 1, 2013 and shall be filed with the Secretary of State.

Amendment to Dog Control – Chapter 45 of the Town Code – Effective 1/1/2013

Last license fee increase was Local Law #4 of 1985 -

Local Law #3 of 2010 increased the spayed/neutered license by a \$1.00 to satisfy NYS Ag and Markets surcharge.

Section 45-7- Fees

License Increases as follows:

Spayed/Neutered - \$7.00 to \$10.00 Unspayed/Unneutered - \$15.00 to \$20.00

- Section 1. The Local Law increasing dog license fees is hereby amended by adding thereto the following:
- A. The following additional fees are hereby established for pure bred licenses issued in the Town of Albion:
 - Five (\$5.00) Dollars if no more than ten (10) registered pure bred dogs or pure bred dogs eligible for registration over the age of six (6) months are harbored on the owners premises at the time of application;
 - (2) Ten (10.00) Dollars if no more than twenty-five (25) registered pure bred dogs or pure bred dogs eligible for registration over the age of six (6) months are harbored on the premises at the time of application; or
 - (3) Fifteen (\$15.00) Dollars if more than twenty-five (25) registered pure bred dogs or pure bred dogs eligible for registration over the age of six (6) months are harbored on the premises at the time of application.
- Section 2. The above mentioned local fees are in addition to the State fees established by the Agriculture and Markets Law of the State of New York.

Local Law No. 4 of 2004 Amendment and Addition to Chapter 45 – Dogs

Be it hereby enacted by the Town Board of the Town of Albion as follows:

Section 1: Section 45 - 6(A)(7) of the Town Code is amended to read in its entirety as follows:

§45-6(A)(7) Remain unlicensed after the age of four (4) months, or for said owner to fail to renew any dog license as required by this Chapter.

Section 2: Section 45 - 12 of the Town Code is added in its entirety as follows:

§45-12 Dog Enumeration

The Town of Albion will conduct a dog enumeration every three years. In addition to other fees assessed under this Chapter, a \$5.00 extra fee will be collected with the license fee for each dog found unlicensed during the dog enumeration.

Section 3: This Local Law shall be effective upon filing with the Secretary of State in accordance with the Municipal Home Rule Law.

- (b) Engage in habitual and loud howling, barking, crying or whining or conduct as to unreasonably and habitually disturb the comfort or repose of any person other than the owner of such dog.
- (c) Uproot, dig, or otherwise damage any vegetables, lawns, flowers, garden beds, or other property without the consent or approval of the owner.
- (d) Chase, jump upon or at or otherwise harass any person in such manner as to reasonable cause intimidation or fear or to put such person in reasonable apprehension of bodily harm.
- (e) Habitually chase, run alongside of or bark at motor vehicles, motorcycles or bicycles while on a public street, highway, or place, or upon private property without the consent or approval of the owner of such property.
- (f) Create a nuisance by defecating, urinating or digging on public property, or on private property without the consent or approval of the owner of such property.
 - (g) If a female dog, when in heat, be off the owner's premises, unrestrained by a leash.
- (h) Remain unlicensed after the age of four months, or for said owner to fail to renew any dog license as required by this article.
- (i) Be at large on any school premises or recreational areas, or the sidewalks adjacent thereto, unless the dog is on a leash.
- 2. Establishment of the fact or facts that a dog has committed any of the acts prohibited by this article shall be presumptive evidence against the owner or harborer of such dog that he has failed to properly confine, leash or control his dog.

Section 6: Licensing of Dogs:

- (a) All dogs in the Town of Albion must be licensed with the Town Clerk by the age of 4 months and are required to present a current Certificate of Rabies at the time of licensing or the renewal of an existing license. A spay/neuter certificate, if applicable, must be presented at the time of original application or renewal of the license.
- (b) All dog licenses will be for a period of one year and will expire at the end of the month one year from the date of issue.

Section 7: Fees for Licensing of Dogs:

- (a) The fee for a spayed or neutered dog will be \$7.00, (which included the assessment of a \$1.00 surcharge for the purpose of carrying out animal population control) and the fee for an unspayed or unneutered dog will be \$15.00, (which included the assessment of a \$3.00 surcharge for the purpose of carrying out animal population control) with such fees being reviewed by the Town Board periodically and may be changed by a resolution of the Town Board, if deemed necessary.
- (b) Purebred License: The Town of Albion will be issuing Purebred or Kennel Licenses. Purebred license fees are \$30.00 for no more than 10 dogs, \$60.00 for 11 to 25 dogs and \$120.00 for more than 25 dogs. In addition to the above fees a surcharge of \$1.00 per spayed/neutered or \$3.00 per unspayed/unneteured will apply for each dog listed on the purebred license. Purebred is AKC or UKC only.
- (c) Enumeration fee: When the Town Board determines the need for a dog enumeration, a fee of \$5.00 will be assessed to all dogs found unlicensed at the time the enumeration is conducted.
 - (d) Tag replacement fee shall be set at \$3.00 and must be paid at the time of application.
- (e) Fees for Seizure of Dogs: The fee for seizure and impoundment of dogs in violation of this law or the laws of the New York State Department of Agriculture and Markets Law shall be required to pay the same impoundment and euthanasia fees per animal that are set forth in §117 of said Article 7 of the Agriculture and Markets Law.
- (f) Service Dogs: The Town of Albion will not require a license for any guide dog, service dog, hearing dog or detection dog.
- (g) The Town of Albion will allow the licensing of dogs by the Orleans County Animal shelter. All dog licenses shall be transmitted monthly to the Town of Albion for dogs that will be harbored within the Town of Albion.
- (h) All dog licenses may be purchased by visiting the Town offices or by regular mail. If licensing or renewing a license by mail, the appropriate fee must accompany the forms. There will be NO refund of fees.
- (i) All fees will be used in funding the administration of the Dog Control Law of the Town of Albion. All fees listed in this Section may be reviewed by the Town Board periodically and may be changed by a resolution of the Town Board, if deemed necessary.
