RESOLUTION #67 APPLICATION FOR FUNDING FROM THE JUSTICE COURT ASSISTANCE PROGRAM

WHEREAS the Albion Town Court is requesting authorization from the Town of Albion through the Albion Town Board to apply for funding from the Justice Court Assistance Program (hereinafter referred to as JCAP) during the upcoming granting cycle; and

WHEREAS one required component of that application is a Resolution from the Albion Town Board authorizing the Albion Town Court to apply for this funding; and

WHEREAS the Division of Professional and Court Services will not accept the Court's application unless this Resolution is passed with the deadline application being October 13, 2023.

NOW THEREFORE BE IT RESOLVED:

Section 1 The Albion Town Board authorizes the Albion Town Court to apply for JCAP grant in the 2023-24 grant cycle up to Thirty Thousand Dollars (\$30,000.00).

Section 2 This Resolution authorizes the Albion Town Court or any of its judges, clerk or clerks to proceed forward with this application.

Section 3 This Resolution also authorizes Albion Town Supervisor F. Richard Remley to sign any documents necessary in order to effectuate the purpose of this Resolution.

Section 4 This Resolution shall take effect immediately.
